## "Submit your Orlando Meeting RFP and Win an iPad Mini"

### Official Rules

1. **No Purchase Necessary.**
2. **To Enter:** There is one way to enter. A) Website Entry: Beginning on June 1, 2017, interested parties (the "entrant") may enter online by visiting [www.orlandomeeting.com](http://www.orlandomeeting.com) and completing and submitting a qualifying meeting RFP at <http://www.orlandomeeting.com/rfp/> to include full name, company/organization name, address, and email address. Each unique RFP qualifies.  
  
Sponsor is not responsible for entries not received due to electronic or technical reasons beyond Sponsor's reasonable control. Limit ONE entry per person per day regardless of method of entry. Entries submitted in violation of the "Win an iPad Mini" official rules, will be void. All entries become the property of Visit Orlando and will not be returned. All entries must be received by 11:59:59 PM ET on September 30, 1, 2017, the official end date of the Sweepstakes.
3. **Eligibility:** This sweepstakes is only open to legal residents of the 50 United States and the District of Columbia, and Canada who are 21 years of age and older as of date of entry. Void in Quebec, Puerto Rico and wherever else prohibited and/or restricted by law. Employees (and their immediate family members) of Visit Orlando, (the "Sponsor"), their affiliates, divisions, related companies, advertising and promotional agencies and any other entity directly associated with this Sweepstakes are not eligible to enter.
